Setting up an Account and Applying to be a Registered Dealer

Once you have completed and faxed your AETech Customer Account Form, Current Business License and Re-Sale Certificate to our office in Poughquag, New York for verification and have placed your First Order, we will open your account. AETech maintains the right to check the vendor references, and if necessary personal credit (by Equifax) and Business Credit (by Dunn & Bradstreet). All accounts will be on a paid in advance basis.

Payment Terms

We also accept all major **Credit Cards**. There are no additional charges or discounts for payment methods.

All orders are accepted under prepayment basis unless otherwise arranged. A service charge of 1.5% per month will be added to past due accounts. Accounts with balances 90 days past due will be turned over for collection and all collection fees and charges incurred will be the responsibility of the dealer. There will be a \$49.00 service fee for any NSF Checks.

Orders

All orders must be faxed to us with payment method. Availability of product ordered will be verified by our staff before shipment. All Advertised Dealer Prices are from our warehouse in Poughquag, New York and do not include any applicable Freight Charges or Taxes.

Minimum Advertised Price

The price list shows the minimum AETech products will be advertised for on the Internet. All re-sellers that sell AETech products to the end user via the Internet or use the Internet for advertising are expected to comply with the minimum advertised price requirements. We will continue to promote and maintain a consistent price in the market and will work with our partners, (Distributors and Dealers) to create and maintain demand for our products in every market. Any breach of this term will immediately be addressed and could result in the cancellation of agreement and repeal of distribution rights. A dealer of AETech Inc is any entity that purchases the minimum order of products and stocks AETech products in their own Retail or Internet Store.

Freight & Drop Ships

All oversized Freight is payable by the buyer unless otherwise arranged. All Drop Shipped orders will incur a \$10.00 Service Fee for orders of less than \$500 plus any Freight Charges.

Claims

Any claims for shortage or broken delivery must be made via fax to our Corporate Office, within "2 days" of the receipt of merchandise. A signature by the buyer or their representative on the bill of lading signifies all merchandise has been received in undamaged and saleable condition, and that all packages have been received. All goods shall be deemed to be in the hand of the purchaser from the time they are placed in the hand of the carrier and consigned to purchaser. Please make sure that you are receiving all the packages shipped and that none are damaged, as once signed for any loss, damage or destruction is assumed by the purchaser.

Force majeure

We will not be responsible or liable for any losses or consequential liabilities arising from delay, inability or failure to fill orders or to perform our obligations caused by acts of god, war, fire, flood, explosion, accident, strike, terrorist acts, or other labor trouble, the exercise of military authority, scarcity of labor materials, transportation difficulties, demand exceeding supply, or any other circumstances beyond our control. If execution of any order is delayed by any such event the time for delivery is to be automatically extended by the same number of days plus 2 more that there shall have been days of delay.
